Recipients of data communication

Retention period

Data will be retained for a period of time no longer than that required to achieve the purpose of their collection and processing, in compliance with the terms prescribed by law. Accounting laws state a retention period of 10 years from the end of the contractual relationship.

For the purposes referred to in point c) until the consent is revoked.

Data Subject's Rights

The Data Subject, by contacting the Data Controller at the address provided, has the right to obtain confirmation of whether or not their personal data is being processed and if so, to:

- request confirmation of the existence of their personal data;
- obtain information as to the purpose of processing; personal data categories; recipients or categories of recipients of personal data to which personal data have or will be communicated and when, possible, the retention period;
- obtain the correction, integration or deletion of their data;
- obtain limits to processing;
- obtain, where applicable, the portability of data, i.e. receive data from Data Controller in a structured, commonly used format for transmission to another controller, without impediment;
- oppose processing at any moment;
- oppose automatic decision-making processes concerning natural persons (including profiling);
- submit complaint to the Privacy Authority in case of irregularities found in processing.
